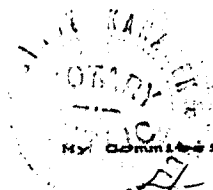

All trailer houses must have under skirting compatible with the exterior finish of the home.

No offensive trade shall be carried on upon any lot nor shall anything be done thereon which may be or become an annoyance or nuisance to the neighborhood. It being the express understanding that Red Oak Hills Subdivision is for residential purposes only. Child care in the home would be permitted.

No animals, livestock, poultry or hogs shall be raised, bred or kept on any lot. Lot 1, Lot 2 and Lot 37 are allowed to have a maximum of 2 cattle or horses or a combination thereof. Cats, dogs, or other household pets may be kept. These pets must be confined to owners premises.

No trucks, cars, or old machinery not in working order shall be left on any given lot unless in a suitable building for more than 30 days.

No foreign objects to be laid on top of trailer houses as it is the desire of all residents to make Red Oak Hills Subdivision a clean and attractive place to live.

Property owners must mow their lots, remove trash on a regular basis and in general keep their property in an attractive condition.

Lots 19 through 36 are reserved for double-wide mobile homes on a permanent perimeter foundation or conventional built homes. All conventional built homes in Red Oak Hills must have at least 1,100 square feet of heated space. Double-wide mobile homes on lots 33 through 36 will be no older than 3 years.

Since it is the desire of lot owners and the lot developer to make and keep this subdivision a clean and attractive place to live, the seller of the lots will retain the right and privilege to inspect the mobile home that the buyer proposes to move on the lot previous to sale of lot. If a lot were sold and a mobile home was to be bought in the future, the seller would still have the right to void the sale if an undesirable home was proposed. If the sale was voided, the down payment and any monthly payments would be refunded to the buyer upon request. The purpose of this covenant is to assure a desirable standard of homes and maintain property values in the area.
