PROTECTIVE COVENANTS

FOR Lots 1 through 64 - TIMBER LAKE ESTATES

Location: Located in part of the W2 of the SE1, Sec. 17, part of the S½ of the NW1, Sec. 17, the SW2 of Sec. 17, and in part of the E2 of the SE1, Section 18 and in part of the SW2 of the NW2 of Section 18, all in Township 19 North, Range 28 West in Benton County, Arkansas

The undersigned Darrow Garner, Inc., being the sole owner of Lots 1 through 64. Timber Lake Estates, does hereby establish and create the following Protective Covenants which shall apply to the above named lots as shown on the recorded plat of Timber Lake Estates subdivision.

I. COVENANTS

- A. Land use and building type: No lot shall be used except for residential purposes.
- Dwelling Size: No dwelling shall be permitted on Lots 44 through 53, and on Lots 62, 63 and 64 with less than 1400 square feet of enclosed living area, and no dwelling shall be permitted on the ramaining lots with less than 1200 square feet of enclosed living area, and at no time shall a mobile home be allowed to be placed on any lot.
- Nuisances: No noxious or offensive activity shall be carried on upon any lot, nor shall anything be done thereon which may be or may become an annoyance or nuisance to the neighborhood. No cattle, sheep, goats, or other farm animals may be kept on the premises, EXCEPT one horse only may be kept on lots less than 5 acres in area, and two horses and one steer may be kept on lots 5 acres or more in area. No breeding of pets for sale may be carried on upon these lots. No car, truck or other vehicle may be dismantled and left on the premises for more than 7 days.
- D. Barns: All barns on less than 5 acre tracts must be placed at least 125 feet from the front property line, and all barns on 5 acre tracts or larger must be placed at least 200 feet from the front property line.

II. GENERAL PROVISIONS

- A. Term: These covenants are to run with the land and shall be binding on all parties and all persons claiming under them for a period of 25 years from the date these covenants are recorded, after which time said covenants will be automatically extended for successive periods of 10 years unless an instrument signed by a majority of the then owners of the lots has been recorded agreeing to change of said covenants in whole or any part.
- B. Enforcement: Enforcement shall be by proceedings at law or in equity against all persons violating or attempting to violate any covenant either to restrain violation or to recover damages.
- C. Severability: Invalidation of any one of these covenants by judgment or court order shall in no wise affect any of the other provisions which shall remain in full force and effect.
